- b) Returns of goods supplied will be on a case by case basis and subject to Bundys approval.
- c) Any expenses, costs or disbursements incurred in recovering any outstanding monies, including debt collection agency fees, legal & solicitors cost will be paid by Me/I/Us. Me/I/Us authorize the production of a new invoice in my/our personal name/s upon failure to pay Bundy's – T/A Rizdon Investments Pty Ltd outstanding invoices at a Company level any unpaid overdue accounts. If I/We/Us trade under some sort of trust/family trust business structure it is agreed to the terms in this application with regard to failure to pay our invoices and re issuing of personal name invoices instead. I/me/we agree to pay the new invoice which presents in the form of a private personal name Invoice to Me/I/Us. I agree to the appropriate collections process involved in personal collection debt processes. I agree that failure to pay this new personal name invoice will result in a potential court order processes which could lead with a warrant being issued to seize property that allows a sheriff to go to my home or business and take non-secured items to sell at Public auction to pay of the overdue personal debt & additional costs.
